Since despite service of notice none appears on behalf of the State respondents, Mr. S. Ghosh, learned advocate, who normally appears on behalf of the State authorities, is requested to appear in this matter. Let a copy of the application be served on Mr. Ghosh which is served and accepted. The Legal Remembrancer, West Bengal is directed to regularise the appointment of Mr.Ghosh.

At the very outset, Mr. G. Halder, learned advocate for the applicant submits that he does not want to press the prayer 8(ii) of the application.

In this application Santanu Ghosh, the applicant who had participated in the selection process for the post of Pharmacist, Grade-III has prayed for certain reliefs, the relevant portion of which is as under :-

"....Directing the respondent authorities to awarding 5 marks in favour of petitioner as the petitioner has experience more than 7 years from the made of application for the post of Pharmacist Grade-III as per advertisement being advertisement No. R/MT/phar/Physio/48/3/2018 and to be appointed the petitioner in the post of Pharmacist Grade-III.."

It is submitted by Mr. Halder that though his client has seven years experience and is entitled to five marks in the selection

process for the post of Pharmacist, Grade-III , however it has not been granted. Submission is leave may be granted to file representation highlighting his grievances before the authorities and the authorities may be directed to consider the same.

Mr. S. Ghosh, learned advocate appearing on behalf of the State respondents submits, if directed, the respondent authorities will consider the matter in accordance with law.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by granting liberty to the applicant to file representation ventilating his grievances annexing copies of documents in support of his grievance along with a copy of this order downloaded from the website of the Tribunal before the Secretary and Controller of Examination, West Bengal Health Recruitment Board, Calcutta, - the respondent no. 3 within four weeks. If representation is filed, same shall be disposed of by the said respondent no. 3 within eight weeks by passing an order to be communicated to the parties, after scrutinising the documents submitted along with the representation and after verifying the records.
