The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Mrs.Mitra, learned counsel without disputing the fact that the deceased employee worked under work charge establishment, however, relies on an order of this Tribunal in OA-40 of 2019. Submission is that both the matters are similar in nature and this Tribunal had set aside the rejection order rejecting employment under the compassionate ground on the ground that the deceased employee was a work charged employee. Copy of the order of this Tribunal in OA-40 of 2019 is in this application.

Responding on behalf of the State respondents, Mr.Mondal, learned counsel refers to clause (f) of 251-Emp dated 03.12.2013, which stipulates that the scheme for compassionate employment is only for those employees who had worked under regular basis. Mr.Mondal also presents a copy of order of this Tribunal in OA-93 of 2021, in which, the Tribunal had clearly mentioned that the legal heirs of a work charged employee are not entitled under the existing rules for an employment under the compassionate ground.
