The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under Section 6 (5) of the Administrative Tribunals Act, 1985.

Heard the counsels for both the parties.

The instant application is regarding compassionate employment to the applicant, Mr. Manoj Bag. The father of the applicant died on 04.11.2011 at the time when the applicant was 10 years old. Although, it appears from the record that the mother of the applicant had made an application regarding compassionate appointment to the minor child when he would attain majority. Based on the application for compassionate appointment made by the mother of the applicant, the petitioner, Manoj Bag was called for written test as well as interview under exempted category from January to March, 2012. However, Home & Hill Affairs Department on 03.04.2018 communicated the rejection order citing the guidelines of Labour Department's Notification No. 251-Emp dated 03.12.2013.

The relevant portion of the Notification is as hereunder:-

"The dependent member shall invariably attain the minimum age for recruitment within six months from the date of death or incapacitation of the concerned employee"

submitted a citation of Hon'ble Apex Court reported in (1996) 1 SCC 301 where the Apex Court has held ...

"Since the death occurred way back in 1971, in which year the appellant was four years old, it cannot be said that he is entitled to be appointed after he attained majority long thereafter."

Leaned advocate submits that since the respondent has submitted in his prayer is financially in dire straits and very much needed an employment, for this, the application of the petitioner may be considered afesh.
