In this matter Uttam Kumar Chatterjee, the applicant, an Upper Division Clerk in the office of the Freshwater Fisheries Research and Training Centre, Kalyani, West Bengal, who had superannuated on 31st December, 2015, has prayed for disbursement of pensionary and retirement benefits including Provident Fund and Gratuity.
