The matter is taken up by the single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020 and 456-WBAT/2J-15/2016 dated 16th July, 2021 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunal Act, 1985.

In this application Ujjal Mondal, the applicant, belonging to General Category, has prayed for certain directions, the relevant portion of which is as under:-

".....a) An order/issue a writ upon concerned respondent authorities of forthwith allow the applicant to join at his post of contractual driver at Bidhannagar Police Commissionerate. Pursuant to his selection and submission of VR form dated 19.08.2020.

b) An order/issue a writ to publish the merit list with all the details of the candidates....".

It appears that the Commissioner of Police, Bidhannagar Police Commissionerate had issued notification for recruitment of forty contractual drivers. The applicant applied for

the same. The grievance of the applicant is that though he was selected and has submitted the VR From on 19th August, 2020, till date he is unaware of the result of his application for appointment.

Mr. M.N. Roy, learned advocate for the State respondents submits that though initially the advertisement was made for forty posts for contractual drivers, ultimately it was decided to appoint thirty drivers on contractual basis. Assuming the applicant was selected, mere selection does not give any right to the post, which is contractual. Further, the applicant has not annexed the merit list.

Having heard the learned advocates for the parties and considering the facts and circumstances of this case, the application is disposed of by directing the Deputy Commissioner of Police (H.Q), Bidhannagar Police Commissionerate, - the respondent no. 7, to give reply to the letter dated 12th February, 2021 issued by the applicant appearing at pages 30 and 31 of the application, within fifteen weeks from the date of presentation of a copy of this order downloaded from the internet.
