The matter is taken up by the single Bench pursuant to the Notification No.949-WBAT/2J-15/2016 dated 24th December, 2020 issued in exercise of the powers conferred under Sub-Section (6) of Section 5 of the Administrative Tribunals Act, 1985.

The matter being OA 31 of 2019 (Rita Chatterjee –v- The State of West Bengal & Others) was disposed of by the Tribunal by order dated 19th February, 2019 by directing the Commissioner of Commercial Taxes, Government of West Bengal to take necessary steps for grant of family pension in favour of the applicant within a period of 12 weeks and to take necessary follow-up action for grant of arrears of family pension within 8 weeks thereafter. Aggrieved, the State respondents filed a writ petition before the Hon'ble High Court being WPST No. 183 of 2019 (State of West Bengal –v- Smt. Rita Chatterjee and Another), which was disposed of on 6th January, 2021, by setting aside the order passed by the Tribunal on 19th February, 2019 and remitted the matter back to the Tribunal for hearing on merits after affording opportunity to the parties to file their reply to the original application.
