The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The prayer in this application is for setting aside the respondent's order passed on 05.09.2016 by the respondent, Commissioner, Textiles & Sericulture, West Bengal in terms of the Tribunal's order. This reasoned order had rejected the application for compassionate employment on the ground that the applicant's deceased father working as Resham Karmee was never absorbed in regular establishment. The reasoned order also states that the receipt of pensionary benefit does not create any right of appointment under compassionate ground.

Mr.D.K.Mukherjee, relies on the fact that since the applicant received the pension, therefore, it is to be accepted that he was under regular establishment.

Mr.M.N.Roy, however, controverts this statement with the submission that receiving pension does not confer on an employee the status of permanent employee and pension does not entitle a family member for compassionate employment.

Mr.M.N.Roy, also refers to page No. 32 which appears to be order of the department issued on 06.07.2000, in which as a policy, the Government has declared the Resham Karmees not being eligible for compassionate employment on the ground that these posts are supernumerary posts and such post will cease to exist as and when the Resham Karmee dies or retires.

Mr.M.N.Roy, submits that this order was never challenged by any of the applicants and this order is still in force.

After hearing the submissions and considering the facts and circumstances of the case, the Tribunal is of the opinion that since the applicant's deceased father was not an employee in a permanent capacity and absorbed in any regular establishment, the application for compassionate employment has no merit. Moreover, receiving pension does not give any right to the applicant to claim compassionate employment.

Accordingly, the application is disposed of.
