The matter is taken up by the single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020 issued in exercise of the powers conferred under sub section (6) of section 5 of the Administrative Tribunals Act, 1985.

Let affidavit of service filed be kept on record.

In this application Rajsekhar Das, the applicant, has prayed for a direction upon the respondents to give appointment on compassionate ground. It appears that the mother of the applicant Kamini Bala Das working as Health Supervisor (Female) in Block Medical Officer of Health, Patashpur-II, in the district of Purba Medinipur had expired on 20th August, 2017 leaving behind the applicant, his father and one married sister and one unmarried sister. Thereafter, on 12th August, 2018 the applicant made an application for service in the dying in harness category before the Block Medical Officer of Health, Patashpur, - District – Purba Medinipur, - the respondent no. 4. It appears from page 23 of the application that the Chief Medical Officer of Health, Purba Medinipur, – the respondent no. 3 had accepted the application of the applicant for employment on compassionate ground by memo dated 15th November, 2018. It is submitted by Mr. B.B. Maity, learned advocate for the applicant that since the application for appointment on compassionate ground is pending since 2018, appropriate order may be passed.
