The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

Mr.G.C.Chakraborty, learned advocate for the applicant submits that since the matter relates to grant of voluntary retirement and consequential payment of pension and as in spite of direction, no reply has been filed on behalf of the State respondents, the application may be allowed.

Mr.S.Ghosh, learned advocate appearing on behalf of the State respondents relying on interim order passed on 3rd March, 2020 in W.P.S.T. 193 of 2019 (The State of West Bengal and Others vs. Dr. Aniruddha Ghorai) submits as the issues in writ petition before the High Court and the issue involved herein are similar, the matter may be adjourned as the matter is pending before the High Court.

Mr.Chakraborty, submits that the instant application relates to grant of voluntary retirement and not with regard to interpretation of Rule 75 and its various sub rules of West Bengal Service Rules Part-I pending before the High Court.

Since in spite of direction passed on 24th September, 2021 no reply has been filed, as a last chance time to file reply is extended till 6th May, 2022.
