It appears from the record and submission of the learned counsel of the contesting parties that the aforesaid matters are related to the same and identical issue. Accordingly, all the cases as item Nos. 30 to 41 and 44 to 64 of today's cause list are taken up together for consideration and a common order is passed in all the aforesaid matters.

Sri S.N. Ray, learned counsel appearing for the State Respondents submitted that till date no instruction has yet been received for which, no reply is filed. It appears from the order of the Hon'ble Tribunal passed on the last occasion that a last chance was given to the State Respondents to file reply against the aforesaid original applications.
