The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 536-WBAT/2J-15/2016 dated 26<sup>th</sup> August, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

In the instant application has been filed basically praying for stay on disciplinary proceeding dated 26.10.2018 till the disposal of the criminal case being Kasba P.S.(DD) Case No. 197 dated 06.06.2018 under section 120B IPC read with 25(IB)(a)/35 Arms Act 1959 as well as praying for a direction to the respondent authority to change the Enquiry Officer.
