The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Affidavit of service filed be kept on record.

The amended prayer is for a direction to the Respondent No. 2(i), the Principal Secretary, Department of Agriculture to issue the employment letter to the applicant in terms of the Reasoned Order passed by the Commissioner of Textiles and Sericulture dated 23.12.2022.

Submission of Mr. Mukherjee, learned counsel for the applicant is that in terms of direction of this Tribunal, the Commissioner of Textiles and Sericulture had passed a Reasoned Order dated 23.12.2022 in favour of the applicant, Pranab Mandal recommending for him employment under compassionate ground. During examination of this Reasoned Order, the Tribunal observes the conclusive part, which states that :

“Now, after careful consideration of the facts of the present case, substantiated by reports and records and in reference to the notification, vide 26-EMP, dated 1<sup>st</sup> March, 2016 r.w. 251-EMP, dated 03.12.2013 of the Employment Cell of the Labour Department, government of West Bengal and; I, hereby put on record that, the applicant-cum-petitioner, Sri Pranab Mandal, son of the Late Swapan Mandal is recommended for employment on compassionate ground subject to availability of suitable vacancy & other qualifying criteria and all papers in this regard be sent to the Administrative Department”.

Since the applicant's prayer for compassionate ground has been recommended, subject to vacancy and fulfilling all the criteria, the proposal now lies with the Department of Agriculture for taking the final decision, this
