Banerjee, learned advocate appearing on behalf of the State respondents referring to the memo dated 13th May, 2022 appearing from pages 16 to 21 of the application submits since the matter relates to “Departmental promotion” in “West Bengal Dental Education Service, 2022” and is regarding departmental promotion for the posts of Professor and Assistant Professor and as the applicant has not categorically shown that he belongs to the cadre of “West Bengal Dental Education Service” or former dental service, no interim order
