The matter is taken up by the single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020 issued in exercise of the powers conferred under sub section (6) of section 5 of the Administrative Tribunals Act, 1985.

As prayed for by Mr. M. N. Roy, learned advocate for the applicant, leave granted to correct the cause title of the affidavit of service. Leave also granted to correct the cause title of the application so far as the respondent no. 1 is concerned.

Affidavit of service filed today be kept on record.

Mustafa Sk., Rearing Attendant of Boswa Sericulture Composite Unit, Birbhum, the applicant, who had superannuated on 31st January, 2018, has prayed for several reliefs, the relevant portion of which is as under:

"A) An order be passed by directing the respondent authority to release the arrear salary/dues of the applicant during his suspension period with effect from 28.10.1998 to 31.07.2012 along with 18% interest over the said amount on the basis of Memo dated 313/Seri/Suri dated 30.07.2019 which was issued by the respondent no. 3 of the instant

application i.e. Deputy Director of Textiles (Sericulture), Suri, Birbhum, Pin-731101, addressed to the respondent no. 2 of the instant application i.e. the Commissioner of Textiles (Sericulture), 45, Ganesh Chandra Avenue (2nd Floor), Kolkata-700 013, being made Annexure-L of this application.

B) An order be passed by directing the respondent authority to consider the representation dated 22.11.2019 made by the applicant before the respondent no.3 of the instant application i.e. Deputy Director of Textiles (Sericulture), Suri, Birbhum, Pin-731101, and the same is still pending for proper adjudication."

Admittedly the applicant has received the superannuation benefits. It appears that the applicant was arrested by police on 28th October, 1998 and a criminal case was lodged which ended in acquittal from the charges by judgment delivered by the learned Judicial Magistrate, 1st Court, Rampurhat, dated 29th November, 2017 in G. R. case No.444/98 under Section 379 and 411 of Indian Penal Code. Thereafter, the applicant joined his duties on 1st August, 2012 vide Suspension Revocation Order dated 27th July, 2012, passed by the Joint Director of Sericulture, West Zone, Bolpur, Birbhum. It appears that after being arrested he was under suspension from 28th October, 1998 till 31st July. 2012, during the said period he was allowed 50% of his pay and allowances as per Rule. Referring to the intimation dated 30th July, 2019. issued by the Deputy Director of Textiles (Sericulture), Suri, Birbhum, being annexure-'L' to the application, it is submitted by Mr. M. N. Roy, learned advocate for the applicant since the applicant has been acquitted, the balance 50% of arrear pay and allowances be released as the Deputy Director of Textiles (Sericulture), Suri, Birbhum, in the said letter dated

30th July, 2019, has intimated the Commissioner of Textiles (Sericulture) -the respondent no. 2 to grant administrative approval to make payment.
