The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6(5) of the Administrative Tribunals Act, 1985.

The Legal Remembrancer, West Bengal is directed to regularise the appointment of Mr. G.P. Banerjee, learned advocate appearing on behalf of the State respondents.

In this application, Ranjit Kumar Mandal, the applicant who joined as Lecturer on contract basis in Jalpaiguri Government Engineering College on 19th December, 2001and at present working permanently as Assistant Professor in Computer Science & Engineering Department, Government College of Engineering & Ceramic Technology, Kolkata, West Bengal has prayed for several reliefs, the relevant portion of which is as under:-
