The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

After the death of his father while in service as Resham Karmee on 11.09.1999, the applicant submitted his plain paper application on 23.09.1999 and later on 15.01.2009 the proforma application was submitted. The legal heir certificate mentioning the applicant as son of the deceased employee was issued by the District Magistrate, Jalpaiguri on 22.08.2022. It is also seen in the record that the applicant was asked to submit the relevant documents by the Deputy Director of Sericulture, Jalpaiguri through letter dated 24.05.2022. As advised, the applicant submitted all relevant documents before the respondent, Deputy Director of Sericulture through a letter dated 31.05.2022. Submission is that since no further action has been taken by the authorities, the concerned respondent authority may be directed to consider his prayer for compassionate employment at the earliest.

Hearing the submission of Mrs.S.Agarwal, Mr.M.N.Roy, learned counsel agrees that if a direction is given to the respondent authority, the

same will be complied as per rules.
