Pursuant to the directions contained in the order dated 17th June, 2022, the Chief Secretary to the Government of West Bengal and the Additional Chief Secretary to the Government of West Bengal, Personnel & Administrative Reforms Department, the respondent nos. 2 and 3 respectively have filed a status report dated 25th July, 2022 regarding reservation of posts for transgender community in the State of West Bengal in view of the directions of the Supreme Court in National Legal Services Authority v. Mr.M.N.Roy, learned advocate for the applicant submits that the applicant has applied for participating in the West Bengal Civil Services Executive Examination, 2022 in the offline mode and as the State respondents are taking steps for initiating recruitment process direction may be issued upon the respondents to frame rules under the Transgender Persons (Protection of Rights) Act, 2019 at the earliest. Submission is that the applicant has changed his status in the Identity Card issued by the Election Commission of India and under the heading "Sex" it has been mentioned as "other". Submission is leave may be granted to file an affidavit annexing a copy of the Identity Card issued

Let the matter appear under the heading "Admission Hearing" on 26th August, 2022.
