The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 536-WBAT/2J-15/2016 dated 26<sup>th</sup> August, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The instant application has been filed basically praying for implementation of own order of the respondent. As per the applicant, vide Memo dated 19.02.2021 (Annexure-B), the Director of Health Services, West Bengal had asked the Block Medical Officer of Health, Panchagram Rural Hospital, Diamond Harbour, Block-I to refix the pay at Rs.4325/- in the scale of pay of Rs.3600-7050/- instead of Rs.4200/- with effect from 05.06.1997 by way of recording the same in the original Service Book of the applicant and to do the needful. Subsequently, again the Director of Health Services, West Bengal vide his letter dated 22.09.2021 had again requested the Block Medical Officer of Health to record the same in the original Service Book of the applicant and to send it to the Principal Accountant General (A&E), West Bengal for further course of action. As per the applicant, however, the Block Medical Officer of Health is sitting tight over the order of his superior and till date, no action has been taken.

In view of the above, the counsel for the applicant has prayed that it would suffice his purpose if the Block Medical Officer of Health would be directed to implement the order of the Director of Health Services, West Bengal dated 19.02.2021 and 22.09.2021 within a stipulated period of time. The counsel for the respondent has no objection to such proposition.

Heard the parties and perused the records. It is noted that the Director of Health Services, West Bengal had directed that the pay of the applicant should be refixed at the pay of Rs.4325/- in the pay scale of Rs.,3600-7050/-

with effect from 05.06.1997 after putting the same in the original Service Book of the applicant and to send it to the Principal Accountant General (A&E), West Bengal for further action of payment. However, as per the applicant, till date, the Block Medical Officer of Health has not taken any step in this regard.

In view of the above, the Respondent No. 4, the Block Medical Officer of Health, Panchagram Rural Hospital, Diamond Harbour, Block-I is directed to implement the order of the Director of Health Services, West Bengal dated 19.02.2021 and 22.09.2021 and take appropriate steps within a period of four weeks from the date of receipt of the order.

Accordingly, the OA is **disposed of** with no order as to costs.
