The matter is taken up by the single Bench pursuant to the order contained in the Notification No.638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under section 5(6) of the Administrative Tribunals Act, 1985.

Supplementary application is filed. Copy served.

From the submissions of the learned counsels and the records referred to in this application, the following have emerged as important milestones in the history of this case.

1. By office order No.250 dated 01.12.2003, the West Bengal Police Directorate allowed Bharat Chandra Mandi, a typist and father of the applicant to retire as an invalid person with effect from 06.11.2003 (permanent incapacitation).
2. In a plain paper and handwritten application, the father of the applicant, addressed to the DIG (O), Writers Building, Kolkata dated 17.11.2004, prayed for an employment for his son, the present applicant. No signature or seal, indicating this letter was received is visible on the body of this paper.
3. A typed letter dated 18.06.2007 from Bharat Chandra Mandi, the father of the applicant, is addressed to the Special Inspector General of Police and D.I.G. (O) praying for appointment of his son, Sisir Mandi, the applicant in a job on compassionate ground. This letter refers to Memo 499/Estt. dated 14.06.2007 by which it is understood that the applicant's side was asked to submit such prayer in the prescribed format.

From the records cited above, the Tribunal finds it necessary that the cited Memo No.499 / Estt. dated 14.06.2007 should be examined. Hence, a direction is passed to the
