The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

The applicant has prayed for a direction to the respondent authorities to take decision relating to his prayer for voluntary retirement w.e.f. 03.01.2012. Submission of Mr. Sarkar, learned counsel for the applicant is that way back on 02.01.2012, the applicant had furnished a prayer requesting for acceptance of voluntary retirement. Copy of such prayer available in this application shows that such prayer was addressed to the Superintending Engineer, State Highway Circle No. VI, P.W (Roads) Directorate, Midnapore. The applicant had worked as a "Work Guard" and due to physical ailments, he could not continue his duties from 02.01.2012. The fact of the applicant having submitted such a prayer is also evident from a correspondence made by the Superintending Engineer to the Chief Engineer (HQ), Establishment Branch, Khadya Bhavan vide Memo No. 19/E-31 dated 06.01.2023 mentioning service details of the applicant. Superintending Engineer had requested for taking suitable action in the prayer for voluntary retirement.
