The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The applicant has prayed for a direction to the respondent authorities to expedite his application for an employment under compassionate ground. The father of the applicant had worked as Resham Karmee and died while in service on 02.05.20212. As per submission of Mrs.S.Mitra, the applicant had submitted a plain paper application praying for such employment before the authorities on 08.05.2014. Submission is that despite such representation, the respondent authorities has neither approved the employment nor intimated any updates to the applicant. However, appearing on behalf of the respondent authorities, Mr.S.Bhattacharya, learned counsel informs that this application suffers from serious deficiencies. For instance, the two brothers of the applicant also being family members have refused to give their NOCs' to the applicant for such employment. However, Mr.S.Bhattacharya submits that though a plain paper application was submitted, but the prescribed proforma application has not been submitted till date.
