It also appears that during the subsistence of the first wife the deceased employee had solemnized another marriage with Amala Ram and has a girl child naming Dimpi Ram. From the Declaration Form of the Family Pension, the name of Dimpi Ram, the daughter of the second wife is also mentioned.

After hearing the submissions of the learned counsels and examining the records, this application is disposed of by directing the Respondent No. 4, Dy. Director of Health Services (E & S), Central Medical Stores, Deptt. of Health & Family Welfare, Govt. of W.B., 141, A.J.C. Bose Road, Kolkata -14 to disburse the admissible dues of Gratuity, Group Insurance-cum-Savings Scheme, Leave Salary and G.P.F. in favour of the applicant Mina Ram as per rules within a period of three months from the date of communication of this order.

Accordingly, this application is disposed of.
