It appears that the applicant took part in the selection process for the post of Lady Constable conducted by the West Bengal Police Recruitment Board in the year 2013. After having succeeded in the written test, the applicant was selected for the interview. Thereafter by memo. dated 18th November, 2014 it was intimated that she had been selected for appointment, being Annexure-F to the application. After police verification she was requested to join on 31st January, 2015. However, as she fell ill, she could not join. Subsequently, she made representations dated 1st December, 2016 and 11th December, 2019, being Annexure- J and K to the application, before the Superintendent of Police, Paschim Medinipur, the respondent no. 5 to allow her to join.

It is submitted by Mr.R.Bhattacharya, learned advocate for the applicant that since the applicant fell ill and could not join the post, appropriate direction may be issued upon the respondent no. 5 to allow her to join the post after considering the said representations filed.

Mr.G.P.Banerjee, learned advocate appearing on behalf of the State respondents submits on instruction that since the applicant on 31st January, 2015 or soon thereafter did not join the post and the posts have been filled up and thereafter several recruitment processes for the subsequent years have taken place, no order may be passed.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Superintendent of Police, Paschim Medinipur, the respondent no. 5 to give a reply
