The matter is taken up by the single Bench pursuant to the Notification No.949-WBAT/2J-15/2016 dated 24<sup>th</sup> December, 2020 issued in exercise of the powers conferred under sub-Section (6) of Section 5 of the Administrative Tribunals Act, 1985.

Heard Mr.K.Chakraborty, learned advocate for the applicant and Mr.G.P.Banerjee, learned advocate for the State respondents. It appears that earlier the applicant had moved the Tribunal on the self same issue where an order was passed in OA-815 of 2018 wherein the Tribunal declined to grant relief. Being aggrieved, the applicant moved a writ petition being no. WPST-349 of 2011 which was disposed of on 4<sup>th</sup> January, 2012 by holding inter alia *“If the concerned Department requires service of any Part Time Sweeper, they may consider the case of the petitioner.”*

It is submitted on behalf of the applicant that since it is evident from the Memo. dated 23<sup>rd</sup> August, 2016 that sweepers are required for engagement at MES-III, P.W.Dte. Department on part time basis, appropriate order may be passed.

Mr.G.P.Banerjee, learned advocate for the State respondents submits that if directed, the respondent authority will consider the matter in accordance with law.
