In the application Manoj Kumar Chatterjee, the applicant has prayed for several reliefs, the relevant portion of which is as under:-

".....(i) A Direction be passed upon the respondent authorities to declare/publish the entire result of the selection cum-merit list as regard appointment of Constable (male) in West Bengal Police – 2019 and thereafter to appoint your applicant as per merit list upon setting aside the rejection result forthwith;

(ii) A direction upon the authorities to assign the specific reasons for non-selection of the applicant in the post of Constable (male) in West Bengal Police- 2019 upon producing records, papers and documents before this Hon'ble Tribunal so that conscionable justices may be rendered upon hearing all the parties;

(iii) A direction upon the respondents to appoint your applicant for the post of Constable (male) in West Bengal Police- 2019 in accordance with law....".

De, learned advocate for the applicant since the issue is covered by the judgement delivered on 28<sup>th</sup> January, 2022 in OA 430 of 2020 (Akash Bhunia and others – versus-The State of West Bengal and others) where the panel for the recruitment to the post of Constable in West Bengal Police (Male), 2019
