The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

Mr. M.N. Roy, learned advocate for the applicants submits that the transfer order dated 22nd June, 2022 may be stayed as the Director, State Council of Educational Research and Training, Government of West Bengal, - the respondent no. 3, does not have the jurisdiction to issue the same.

Mr. G.P. Banerjee, learned advocate appearing on behalf of the State respondents referring to the order dated 22nd March, 2021 passed in OA 224 of 2021 (Janajit Chakraborty – vs- The State of W.B. and others) submits since the power of the State respondents to issue such order has been upheld by the said order and the High Court by order dated 21st June, 2021 passed in W.P.S.T. No. 40 of 2021(Janajit Chakraborty – versus- The State of West Bengal & Ors) did not interfere with the order passed, no interim order may be passed. Submission is that the matter is barred by the principles of resjudicata, which is disputed on behalf of the applicant. Mr. Roy submits that the matter may be admitted and be heard on merits.

The matter is admitted. Let reply be filed by 12th September, 2022.
