The matter is taken up by the Single Bench pursuant to the order contained in the Notification No.638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under section 5(6) of the Administrative Tribunals Act, 1985.

The applicant has filed this application praying for a direction to the respondent authorities to release the enhanced revised pension of Rs.25,350/- with effect from 01.01.2020 and balance gratuity amount of Rs.1,39,355/-, balance commuted value of pension. Learned counsel for the applicant draws attention to the correspondence of the C.D.P.O., Chandrakona-I, I.C.D.S. Project, Paschim Medinipur. In this correspondence a revised pension with effect from 01.01.2020 has been proposed before the Principal Accountant General. Submission is that despite lapse of four years, such revised pension has not been issued to the applicant.

Responding to the prayer in this application, Mr. Biswanath Mitra, learned Departmental Representative presents a copy of memo dated 18.04.2022. Mr. Mitra submits that as is evident from this correspondence, the C.D.P.O. has been requested to clarify as follows:

“Non payment declaration by Drawing & Disbursing Officer” and IPF document in terms of Notification No.55-F(Pen) dated 21.01.2020 read with clarificatory order No.120-F(P) dated 03.03.2020 may be furnished.”

The above correspondence has been followed with a reminder issued by the office of the Principal Accountant General on 25.09.2024.
