The matter is taken up by the Single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020, issued in exercise of the powers conferred under sub section (6) of Section 5 of the Administrative Tribunals Act, 1985.

Affidavit of service is filed by the applicant be kept on record.

The instant application has been filed for the second time praying for a direction upon the respondents to take final decision with regard to the compassionate appointment of the applicant. the respondents further submits that they have already communicated the latest status to the applicant on 18.02.2021. However, the counsel for the applicant is vehemently objected to such contention and has submitting that his client has not received the said communication till date.

During the course of the hearing, the counsel for the applicant has further submitted that it would suffice his purpose if the Additional Chief Secretary, Department of Panchayat and Rural Development would be directed to take appropriate steps to communicate the final decision with regard to the compassionate appointment of the applicant within a stipulated period of time.

In view of the above, the Additional Chief Secretary, Department of Panchayat and Rural Development is directed to take appropriate steps to communicate the final decision with regard to the compassionate appointment of the applicant within a period of 10 (ten) weeks from the date of receipt of the order.

Accordingly, the **OA** is disposed of with no order as to cost.
