The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Liberty is given to correct the cause-title in both the applications during the course of the day.

This matter is taken up along with OA 453 of 2023 analogously.

In OA 196 of 2023, the applicant being the brother of the deceased employee, Subhajit Kamila has prayed for a direction to the respondent authorities to offer an employment under compassionate ground. Being the brother and taking care of the aged parents, this younger brother promises to look after the parents if one such an employment is offered to him.

In the analogous matter being OA 453 of 2023, Piu Kamila Mandal being the widow of the deceased employee Subhajit Kamila has also prayed for an employment under compassionate ground. From the records, it appears that the deceased employee Subhajit Kamila served as a Group-D in the department for only around three (03) years and unfortunately committed suicide. An FIR was lodged in the appropriate Court by the mother of the deceased employee against the widow Piu Kamila Mandal for abatement to such suicide of their son. The case is yet to be closed till date. It appears that both the Subhajit Kamila and Piu Kamila Mandal, though being newly married could not sustain their marital life happily. They were living separately and the wife had filed a case against the husband U/s 125 of CRPC.
