The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt. – II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The prayer in this application is for a direction to the respondent to allow monthly remuneration with medical facilities as stipulated in Memo No. 3998-F(P2) dated 15th February, 2019. In this regard, they have submitted their respective applications before the concerned respondents.

Submission of Mrs. S. Agarwal, learned counsel for the applicants is that a direction may be given to the concerned respondents to consider their representations and dispose of the same at the earliest.

Mr. S. Bhattacharya, learned counsel for the State respondents submits that if such a direction be given to the respondents, the same will be abide by as per rules.

directed to submit a fresh representation ventilating their grievances regarding enhancement of remuneration as per Memo No. 3998-F(P2) dated 15th February, 2019 before the Deputy Director, Animal Resources Development & Parishad Officer, Suri, Birbhum, - the respondent no. 2 within three weeks from the date of this order. If such representations are filed before him by the applicants within the time as stipulated, the respondent no. 2 - the Deputy Director, Animal Resources Development & Parishad Officer, Suri, Birbhum, is directed to consider and dispose of these representations as per their entitlement and relevant rules within a period of six weeks from the date these fresh representations are filed before him.

With the above observation, the application is disposed of.
