The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt. – II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

Affidavit of service filed today be kept on record.

The applicant has prayed for setting aside the impugned transfer order dated 11th September, 2024. This impugned order was issued by the State Commandant, W.B. National Volunteer Force Directorate, Kalyani transferring the applicant Assistant Company Commander (GD & Trg) from West Bengal National Volunteer Force Training Centre, Halisahar to West Bengal National Volunteer Force, District Battalion, Murshidabad.

Mr. Banerjee appearing on behalf of the applicant submits that the applicant was transferred to Halisahar very recently on 12.07.2024. By transferring him once again within the period of two months, the Respondent authority has shown arbitrariness and prejudice against the applicant. Such hasty transfer back and forth has not only inconvenienced the applicant and his family but is also misuse of power on part of the Respondent authorities.

Mr. Roy, learned counsel however disagrees and submits that the applicant being a member of uniformed force should always be ready and willing to comply with the directions of his superiors. The transfers were neither arbitrary action nor was intended as a malice towards the applicant.

Mr. Banerjee prays for consideration of the applicant's representation filed before the Inspector General of Police & State Commandant, WBNVF Directorate, Kalynai, Nadia dated 13.9.2024 and further prays for staying the operation of the transfer order dated 11.9.2024. The matter is admitted.
