It is submitted by Mr.M.Karim, learned advocate that though the applicant has not taken loan from the Vidyasagar Central Co-operative Bank Ltd. Goaltore Branch through Goaltore Jute Seed Multiplication Farm Krishi Shramik ECCS Ltd., the respondents have withheld the entire superannuation dues including gratuity. Assuming the applicant has taken loan, the respondents may be directed to release the superannuation benefits minus gratuity.

Mr.M.N.Roy, learned advocate appearing on behalf of the State respondents submits on instruction since the applicant has taken loan, though sanction order was issued, the superannuation benefits have been withheld.
