The matter was admitted on 10<sup>th</sup> July, 2019 when directions were issued for filing of reply and rejoinder. Though opportunities were granted, the respondents till date have not filed reply. On 4<sup>th</sup> April, 2022 an order was passed, which is as under :-

*“...Since factual consideration is required and till date no reply has been filed on behalf of the respondents, as a last chance time to file reply is extended till 2<sup>nd</sup> May, 2022. Rejoinder, if any, by 18<sup>th</sup> May, 2022. If no reply is filed the matter will be heard on the basis of records.*

*Matter to appear under the heading “Hearing” on 6<sup>th</sup> June, 2022...”.*

Mr. G.P. Banerjee, learned advocate appearing on behalf of the State respondents submits though reply has been drafted, however, it could not be filed for reasons beyond control.

We find that the matter is of 2019 and till date, no reply has been filed. Any further adjournment would mean going back from the directions contained in the order dated 4<sup>th</sup> April, 2022.

In this application, the applicants have prayed for certain reliefs, the relevant portion of which is as under :-

*“...A direction be issued upon the respondent authorities, particularly IGR & CSR, West Bengal, the respondent no. 2 herein, to forthwith reassess the answer scripts of the applicants after properly examining the answer scripts of the applicants in consultation with the correct*

*solution sheet to the set question paper(Madhyamik Standard) examination for recruitment of LDC in the establishment of District Registrar, Burdwan sent by the DISSE), Burdwan to the District Registrar, Burdwan vide Memo N0. 220 dated 06.05.2013 and after reassessment on the basis of enhanced marks petitioners shall be given appointment in the post of LDC under District Registrar, Burdwan now Purba Bardhaman... ”.*

Heard Mr. M.M.Das, learned advocate for the applicant.

Since no reply has been filed on behalf of the State respondents , the statements made in the Original Application are deemed to have been admitted by the respondents.

Therefore, as prayed for, the Inspector General of Registration and Commissioner of Stamp Revenue, - the respondent no. 2 is directed to reassess all the answer scripts of the applicants after consulting the correct solution sheet to the set question paper (Madhyamik Standard) for recruitment of LDC in the establishment of District Registrar, Burdwan sent by the DIS(SE) to the District Registrar, Burdwan vide Memo no. 220 dated 6<sup>th</sup> May, 2015 and after reassessment, the order of reassessment shall be communicated to the applicants and if there is enhancement of marks and if the applicant is entitled for appointment to the post of LDC under the District Registrar, Burdwan, it shall be given in accordance with law. This entire exercise shall be completed by the respondent no. 2 within fifteen weeks from the date of communication of a copy of this order downloaded from the website of the Tribunal.

The application is disposed of.
