The instant application has been filed basically praying for review of the suspension order dated 27.12.2019. As per the applicant, she was put under suspension vide order dated 27.12.2019 (Annexure 'A6') under Sub-Rule(3) of Rule 7 of the West Bengal Services (Classification, Control & Appeal) Rules, 1971 as she was detained in custody for a period beyond 48 hours on 23.09.2019 in connection with Chinsurah Women PS Case No. 20/19 dated 23.09.2019 u/s, 498(A)/304B/34 of IPC. Though, subsequently, she has been discharged on bail vide order dated 10.01.2020 of the Hon'ble High Court, Calcutta in C.R.M No. 277 of 2020.

However, till dated, her suspension order has not been reviewed by the competent authority. In the meantime, the applicant had made a representation to the Director of Health Services for re-consideration of her suspension by way of communicating her order of bail. However, as no action has been taken till date, being aggrieved with, she has filed the instant application.

Though affidavit of service has been filed on the earlier occasion today also, none appears for the respondent.

During the course of the hearing, the counsel for the applicant has submitted that it would suffice the purpose of his client if the respondent no. 2 be directed to take decision with regard to his representation by way of reviewing her suspension order and communicate the same within a

stipulated period of time.

In view of the above, the respondent no. 2 is directed to consider the representation of the application dated 25.01.2020 and to take a final decision and communicate the same by way of a reasoned and speaking order with regard to review of her suspension order within a period of 06 (six) weeks from the date of receipt of the order.

Accordingly, the OA is **disposed of**.
