From the submissions made by Mr.R.Khan, learned counsel, it has become obvious that the primary prayer in this application is prayer (b) which is for a direction to the respondent authorities to publish the seniority rules of the unified cadre of WBA&AS post-merger keeping the direct officers of 1999 batch above the mergerist officers who came into WBA&AS in 2001.

Further, the Tribunal's observation is that unless the inter se seniority of two cadres of the officers are published and a combined gradation list is made available, prayer (c) which is for issue of a fresh

notification inviting the applicants to submit applications to the IAS Nominations; prayer (d) Pay protection of direct officers of 1999; prayer (e) Undue promotion given in the scale of Additional Secretary to Mergerist officers & Prayer (f) Direction for giving direct officers of 1999 batch for selection to the post of Joint Secretary in the Scale No. 19 and ROPA 2019 etc. are the issues which can only be covered after prayer (b) is finalised.

Mr.S.Bhattacharjee, learned counsel appearing on behalf of the respondent No. 5, 8 and 9 disputes the claim made by the applicant that they belong to 1999 batch when their date of appointment was made in the month of May, 2001 onwards. The notional merger came into effect on 01.03.2001 prior to the appointment and joining of these applicants in the service.

Since. similar matter has been listed to be heard on 10.06.2025, let this matter also be heard on  $10^{th}$  June, 2025 under the heading 'Hearing'.
