Mr. Gautam Pathak Banerjee, learned advocate appearing on behalf of the State respondents, submits if directed, the Commissioner, Government of West Bengal, Home & Hill Affairs Department, Police Establishment Branch, Howrah, the respondent no.3 shall review the order in accordance with the provisions contained in the notification dated 1st March, 2016.
