The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

In addition, names of Respondent No. 2, the Secretary, West Bengal Group-D Recruitment Board and Respondent No. 4, Chairman, West Bengal Group-D Recruitment Board be deleted from the array of respondents. Let such amendments be made in the application and let copy of this application be served upon the newly added Respondent No. 5, West Bengal Staff Selection Commission by the next date.

Since as per order of this Tribunal dated 18.01.2023, this matter, being a matter relating to appointments, was to be placed and heard today by a Bench comprising two Members (Judicial and Administrative) and since no such Bench is available, let this matter be placed before such a Bench under the heading "**Reply/Rejoinder and Objection**" on **04.12.2024**.
