The matter is taken up by the Single Bench pursuant to the order contained in the Notification No.638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel for the applicant, the case is taken up for consideration sitting singly.

The prayer in this application is for a direction to the respondent, Block Medical Officer of Health, Kulpi BPHC for resumption of duty as Group-D (GDA) and also disbursement of arrears of his wages of having worked during 2015 onwards.

It appears that the applicant was engaged as contingent worker during acute emergency cases as decided in the Block R.K.S. meeting. The applicant has been submitting several representations before the Health Department for payment of his due back wages. It appears that a reference made by the Joint Director of Health Services to the CMOH, Diamond Harbour Health District, enquiring about the working conditions of the applicant. Later the CMOH, Diamond Harbour Health District has asked the BMOH, Kulpi BPHC to certify whether the amount claimed by the applicant as due has been cleared or not.

Submission of Mr. A.B. Chakraborty, learned counsel is that despite a direction by the CMOH, the BMOH has neither replied a letter to the CMOH nor cleared his pending dues.

After hearing the submissions of the learned counsel and perusing the records, the application is disposed of by directing the B.M.O.H., Kulpi BPHC to consider the representation dated 27.02.2021 and dispose of the same as per
