The matter is taken up by the single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020 and 456-WBAT/2J-15/2016 dated 16th July, 2021 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

Affidavit of service filed be kept on record.

In this application, Sukanti Chakraborty –, the applicant, who had superannuated on 31st October, 2008 as Assistant Commissioner of Police, Special Branch, Kolkata Police, has prayed for certain reliefs, the relevant portion of which is as under:

"(a) An order do issue directing the concerned respondent authorities to forthwith release and disburse the gratuity amount in favour of the applicant with statutory bank interest within a stipulated time period, taking into account of the fact that the applicant has retired from sevice on 31.10.2008.

(b An order do issue directing the concerned respondent authorities to forthwith dispose of the representation dated 13th May, 2021 and 17th

June, 2021 praying for release of gratuity putting reliance on the judgments of the Hon'ble Supreme Court of India by passing a reasoned and speaking order after giving an opportunity of hearing and to communicate the decision thereof within a stipulated time period."

Relying on the application, it is submitted by Mr. S. Ghosh, learned advocate for the applicant, that though it is evident from the Pension Payment Order, being annexure 'B' to the application, that he has received the superannuation dues and is drawing full provisional pension, however, gratuity is yet to be released. Though representation dated 13th May, 2021 for release of gratuity was submitted before the Commissioner of Police, Kolkata, the respondent no. 2, being annexure 'C' to the application and thereafter another letter for release of the same was issued on 17th June, 2021, it is yet to be granted. Submission is the respondent no. 2 may be directed to consider the prayer for release of gratuity.

Mr. M.N. Roy, learned advocate, appearing on behalf of the State respondents submits, if directed, the respondents will consider the matter regarding release of gratuity in accordance with law.

Mr. B. Mitra, the departmental representative for the Principal Accountant General (A & E), West Bengal, the respondent no. 4 adopts the submission of Mr. Roy.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Commissioner of Police, Kolkata, the respondent no. 2 to dispose of the representations dated 13th May, 2021 and 17th June, 2021
