The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 496-WBAT/1E-08/2003 (Pt.-II) dated 4<sup>th</sup> August, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

Since despite service of notice, none had appeared on behalf of the State respondents, Mr. G.P. Banerjee, learned advocate who normally appears on behalf of the State respondents, by order dated 25<sup>th</sup> August, 2022 passed by the learned Registrar, was requested to appear in the matter and he appeared on behalf of the State respondents. Today also he appears on behalf of the State respondents. The learned Legal Remembrancer, West Bengal is directed to regularise the appointment of Mr. Banerjee.

In the application Monisha Ghosh, the applicant has prayed for certain reliefs, the relevant portion of which is as under :-

*“(a) ...Directing the respondent authorities concerned, each one of them, their men, agents, servants, subordinates and/or assigns to forthwith transfer the present applicant from Madanpur Sub-centre under Bharatpur-I Block, District – Murshidabad to Veria Sub-centre under Labpur Block, District – Birbhum in terms of the online counselling of transfer dated September 21, 2021.*

*(b) Directing the respondent authorities concerned, each one of them, their men, agents, servants, subordinates and/or assigns to forthwith consider and dispose of the last representation dated April 7, 2022 in accordance with law...”.*
