The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

The applicant has prayed for release of his regular pension along with 50% of arrears withheld from the month of August, 2006. Appearing on behalf of the respondent authority, Mr.G.P.Banerjee, learned counsel files a copy of order of Director of Medical Education dated 11.10.2023 by which a direction has been given to the Principal, Medical College & Hospital, Kolkata, to take necessary steps for sanctioning the pensionary benefits of the applicant. Submission is that since the concerned respondent has already been directed by the Director of Medical Education, the applicant's regular

pension with arrears in full will be released at the earliest.
