In the application, Aditya Mahato, the applicant has prayed for certain reliefs, the relevant portion of which is as under :-

"a)......To set aside and/or quash impugned Speaking Order dated 30.09.2020 as the same is in violation and in contravention to relevant Labour Department Notification No. 251 Emp dated 03.12.2013 read with Department Notification No. 165 EMP dated 04.06.2019;

b) To direct the Respondent Authorities to grant compassionate appointment by relaxing educational qualification as per relevant Labour Department Notification No. 251 Emp dated 03.12.2013 read with Department Notification No. 165 Emp dated 04.06.2019;

c) To direct Respondent Authorities to consider afresh the representation dated 24.09.2019 addressed to them for grant of compassionate appointment by relaxing educational qualification as per relevant Labour Department Notification No. 251 Emp dated 03.12.2013 read with Notification No. 165 Emp dated 04.06.2019....;".

It appears that the applicant, son of Madhusudan Mahato, a peon attached to the office of the Assistant Engineer (A-I), Purulia-II

(AI) Sub-Division Purulia, passed away on 19th June, 2008 leaving behind the applicant and other heirs. The applicant applied for compassionate appointment within the specified time limit. The case of the applicant was considered and it appears from annexure "F" to the application that his name was empanelled. However, it appears from intimation dated 29<sup>th</sup> November, 2017 by the Assistant Secretary to the Government of West Bengal addressed to the Director of Personnel and Ex-officio Chief Engineer, Water Resources Development Directorate, Kolkata, that the State had rejected the application as he was not qualified. It appears that the applicant is class-V pass on 30<sup>th</sup> January, 1990 as evident from annexure "F" to the application. It is submitted on behalf of the applicant that while rejecting the application for compassionate appointment respondents have not considered the notification dated 3<sup>rd</sup> December, 2013 containing the "West Bengal Scheme for Compassionate Appointment, 2013", particularly the stipulation in 'Eligibility', in paragraph (b) thereof, which is as under :-

".....(b) Relaxation in educational qualification may be granted in eligible cases for appointment to Group 'D' post in consultation with the Finance Department....".

We find that the respondents while issuing the order of rejection has not considered the said stipulation for "Relaxation in educational qualification". Therefore, the impugned order contained in the intimation dated 29<sup>th</sup> November, 2017 is set aside and quashed. The application is allowed.
