The matter is taken up by the Single Bench pursuant to the order contained in the Notification No.638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the parties, the case is taken up for consideration sitting singly.

The prayer in this application is for compassionate employment in which it appears that the applicant was found eligible and accepted, which was, however, subject to satisfactory fulfilment of other rules and formalities. It is submitted that, thereafter, the applicant was asked to submit a certificate in computer typing which was also submitted.

Mrs. Sunita Agarwal, learned counsel submits that since 14.06.2022 – the date of submission of the certificate, the respondent has neither offered the employment nor has intimated the applicant. Prayer is for a direction to the respondent to offer employment since the applicant was found eligible and has since submitted the required certificate.

Mr. Soumendra Narayan Ray, learned counsel for the respondents had earlier on two occasions prayed for accommodation to seek instructions from the respondent and submit the latest update in the matter to the Tribunal. However, today Mr. Ray does not seem to be ready to submit the status on behalf of the respondent.

After having heard the learned counsels and considering the fact that the applicant was found eligible and accepted by the respondent, the respondent
