The matter is taken up by the Single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020, issued in exercise of the powers conferred under sub section (6) of Section 5 of the Administrative Tribunals Act, 1985.

The instant MA has been filed praying for a direction to the respondents to continue with the provisional pension as per order dated 29/08/2019 passed by this Tribunal in OA No. 541 of 2019. As per the applicant from perusal of the Memo dated 27.08.2020 (Annexure 'A') to the MA, it would be evident that though she was paid provisional pension from 01.05.2018 to 31.05.2019. However, thereafter, she has not been paid any provisional pension though there was a clear direction from this Tribunal to provide provisional pension even in the Memo dated 27.08.2020, the Principal, Calcutta National Medical College had asked for permission regarding direction for provisional pension to the Director of Medical Education and Ex-Officio Secretary, Department of Health & Family Welfare. However, she is not getting provisional pension since 01.06.2019. Therefore, the counsel for the applicant has prayed that direction may be given to the respondents to provide provisional pension lension till the final disposal of the OA.

The counsel for the respondent has submitted that though as per rules, the provisional pension has been sanctioned each year. However, since there is a court order for granting provisional pension, the respondents are ready to continue with the provisional pension. Heard both the parties and perused the record as well as order dated 29.08.2019, as there was already a
