The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt. II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The learned advocate for the applicant brings to the notice of the Tribunal that on 07.11.2022, a direction was issued to the respondent no. 4 – the Director, Directorate of Industrial Training, under Technical Education, Training & Skill Development Department, Government of West Bengal to consider the application "for release of arrear family pension within six weeks after resolution of the issues pertaining to CAS benefit and fixation of pay."

Today, the learned advocate prays for a direction to the respondent no. 4 to complete the process of application of CAS benefit and fixation of pay within a short time.

Learned advocate for the State respondent submits that there is no need for a new set of directions besides the direction already given to the respondents by the Tribunal on 07.11.2022. However, if any direction is given to expedite the process of the applicant's issues, the same will be considered as per law.

Having heard the learned advocates and considering the fact that the former employee is already deceased, the respondent no. 4 is further directed with reference to the correspondence no. ITI/R/Estt.-
