It appears that the applicant, at present posted as Health Assistant (Male) at South Redokhali Sub-Centre, Canning – I Block, District – South 24 Parganas, has filed a representation dated 17<sup>th</sup> July, 2017 praying for transfer to any place nearer to her residence. It is submitted by Mr. S.N. Ray, learned advocate for the applicant that though representation was made, as evident from page 10 of the application, it has not been considered. Aggrieved, original application has been filed.

Mr. G.P. Banerjee submits, if directed, the respondents will consider the matter in accordance with law.

Having heard learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing Director of Health Service, Department of Health and Family Welfare, Government of West Bengal, the respondent no. 2, to dispose of the representation dated 17<sup>th</sup> July, 2021 by passing a reasoned order to be communicated to the parties within 15 weeks from the date of presentation of a copy of this order downloaded from the website of the Tribunal, after giving an opportunity of hearing and after making necessary enquiry.
