The applicant worked as Assistant Commissioner has prayed for a direction to the Respondent authorities to allow him to retire voluntarily from service for which prayer was furnished by him dated 28.01.2021. From the copies available in this application, the Tribunal observes that the applicant had furnished a representation before the Commissioner, Commercial Taxes on 28.01.2021 praying for voluntary retirement.

The applicant in his representation had narrated the nature of his illness and family compulsion which restricted him from attending office. Since he did not receive any response to his prayer for voluntary retirement, the applicant submitted several reminders to the Respondent authorities. A correspondence No. 2668 dated 24<sup>th</sup> April, 2024 communicated by the Senior Joint Commissioner of Revenue (H.Q.) addressed to the applicant reveals that a reply was yet to be furnished by the applicant giving details of his family members, who are dependent on him. By this correspondence, it is also understood that the applicant was advised to furnish a declaration to the effect that none of his family members will claim for an employment. Attention is also drawn to a reply of the applicant dated 26.4.2024 in
