The matter is taken up by the single Bench pursuant to the Notification No.949-WBAT/2J-15/2016 dated 24<sup>th</sup> December, 2020 issued in exercise of the powers conferred under Sub-Section (6) of Section 5 of the Administrative Tribunals Act, 1985.

As prayed for, leave is granted to the applicant to add the Secretary, Public Service Commission as party respondent by amending the cause title of the original application in course of this day.

At the outset, it is submitted by Mr. A. Das, learned advocate for the applicant that except prayers (d) and (e), he is not pressing other prayers. Submission is that direction be issued on the respondents to consider the representation dated 17<sup>th</sup> August, 2020, filed by the petitioner, appearing at page 48 of the application. Submission is that though the advertisement for enlistment for recruitment of Mass Education Extension Officer and Assistant Director of Mass Education Extension Officer requires 3 years' experience in the field of Mass Education and though the applicant is having 6 years' experience, he has been excluded.

Denying the allegations made in the application, Mr. G.P. Banerjee, learned advocate for the State respondents submits that if directed, the

respondent authorities shall consider the representation in accordance with law.

Heard Mrs. S. Agarwal, learned advocate appearing for the Public Service Commission, West Bengal.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Secretary, Public Service Commission, West Bengal, the respondent no. 7 to dispose of the representation dated 17<sup>th</sup> August, 2020, by passing a reasoned order to be communicated to the parties within 15 weeks from the date of presentation of a copy of this order downloaded from the internet / website after giving an opportunity of hearing to the applicant and after verifying the records. I make it clear that I have not gone into the merits of the matter and all the points are left open to be dealt with by the Secretary, Public Service Commission, the added respondent no. 7.
