The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

Pursuant to the order dated 13th May, 2022, the D.I. of Schools (P.E) Nadia is present in the Tribunal. Mr.A.K.Das Sinha, learned advocate for the D.I. of Schools (P.E) Nadia, the respondent no. 2(iii) submits a clarification / reply. On a query, Mr.Das Sinha submits that no more documents are required from the applicant for resanction of family pension after the death of her husband Sarthak Ghosh on 16th December, 2015 and as his father Meghnath Ghosh is a Government servant.

Mr.B.Mitra, the Departmental representative for the Principal Accountant General (A&E) West Bengal referring to pages 26, 27 and 28 of the Clarification / Reply submits on behalf of the respondent no. 2 (iii) that the applicant is yet to furnish copies with the documents mentioned therein.

Having heard the learned advocates for the parties and the departmental representative and considering the facts and circumstances of the case, the application is disposed of by directing the D.I. of Schools (P.E) Nadia, the
