## THE STATE OF WEST BENGAL & ORS.

It is submitted by Mr. B.R. Neogi, learned advocate appearing on behalf of the applicant that though the applicant is entitled to the benefit of Career Advancement Scheme by upliftment of scale of pay after eight years, sixteen years and twenty five years of service and for re-fixation and revision of pay and for payment of the arrear salary and though a representation dated 3<sup>rd</sup> March, 2020, appearing at page 32 of the application, was furnished before the Director of Health Services, Government of West Bengal, Kolkata, the respondent no.4, however, no steps have been taken. Aggrieved, the Original Application has been filed. Submission is that the said respondent no.4 may be directed to consider the said representation.

Mr. Ghosh, learned advocate for the State respondents submits that if directed, the respondent authorities will consider the matter in accordance with law.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case and as prayed for on behalf of the applicant, the application is disposed of by directing the Director of Health Services, Government of West Bengal, Kolkata, the respondent no.4 to dispose of the representation dated 3<sup>rd</sup> March, 2020 by passing a reasoned order to be communicated to the parties within fifteen weeks from the date of presentation of a copy of this order downloaded from the internet / website after giving an opportunity of hearing and after verifying the records. I make it clear that I have not gone into the merits of the matter and all points are left open to be dealt with by the said respondent no.4.
